

Official Rules for (ISC)² CCSP and CISSP Online Self-Paced Training Course Giveaway:

ELIGIBILITY: To be eligible for the prizes, Entrant must be an attendee at RSA Conference 2023 (RSAC 2023), not an employee of (ISC)², and at least eighteen (18) years of age on the date of the Giveaway entry submission (“Entrant”). In the event more than one (1) Entry is received from any one person per quiz, the first Entry received will be considered the only valid entry received for that Entry Period.
